 - d) I agree not to apply to be an officer, director, partner, shareholder, interested person and associated person or broker of record of a real estate brokerage.
 - e) I agree not to operate as a sole proprietor real estate brokerage.
 - f) I agree to not have signing authority or be designated as an alternate signatory on any statutory trust account established pursuant to subsection 27 of the Act for any real estate brokerage.
 - g) I agree to notify the RECO, in writing, within 5 days of transferring my registration to another brokerage.
 - h) I agree that if these conditions are still in effect at the time of transferring my registration, I shall notify the new brokerage of these conditions, in writing, prior to the transfer of my registration and, ensure that a copy of these conditions are duly signed by my new broker of record.
- 2. I hereby acknowledge and understand that if new or additional information comes to the attention of the RECO related to my honesty, integrity, financial responsibility or compliance with law, or if I breach any of these conditions, the Registrar may take further administrative action, including issuing a proposal to revoke my registration, based on the totality of the evidence of my past conduct. Nothing in these conditions shall prejudice or limit the Registrar's rights under the Act.
