 - d) My BoR and I agree that upon my next application, my BoR will provide the Office of the Registrar, a report summarizing my completed and pending real estate trades and a general comment about the brokerage's level of satisfaction with my conduct as an employee of the brokerage during the first cycle of my registration.
 - e) I agree to complete RECO's Compliance and Ethics in Real Estate course, Part 1 and Part 2 within the second cycle of my registration.
 - f) I agree to notify RECO in writing, within 5 days of transferring my registration to another brokerage.
 - g) I agree that if these Conditions are still in effect at the time of transferring my registration, I shall notify the new brokerage of these Conditions, in writing, prior to the transfer of my registration and, ensure that a copy of these conditions are duly signed by my new BoR. and provided to RECO
 - h) I agree to notify the Office of the Registrar immediately, in writing, of any change to information that was included in my application and shall set out the nature of the change.
 - i) I agree that these conditions will be reviewed no earlier than November 2023.
 - I hereby acknowledge that my non-compliance with any of the agreed upon Conditions may result in a proposal to revoke my registration under the Act which shall be within the sole discretion of the Registrar.

Nothing in these Conditions shall prejudice or limit the Registrar's rights under the Act.
- 4. I agree that a copy of these Conditions will be published on RECO's website and any other place as may be required by law, and/or deemed by the Registrar to assist in protecting the public.
